CALL TO ORDER Board Chair Thomas called the meeting to order at 7:04 p.m.

PUBLIC COMMENT Board Chair Thomas called for public comment.

TREASURER'SJ. Foco said that the Treasurers Report presented is year-to-date as of March 31,**REPORT**2023 for all funds. He shared the following general fund highlights:

The College's three major sources of revenue are tuition and fees, state appropriations and property tax collections. Property tax revenue is projected to come in at projected value. Tuition and fees are anticipated to exceed budgeted projections due to the increase in our contact hours (175,762 excluding CJ courses) versus our budgeted 165,000 contact hours.

Our recorded investment income is higher than budgeted last June. The College originally anticipated rate cuts but, as of now, those did not happen.

In other funds, the auxiliary budgets combined currently reflect a net position of \$42,000 versus a deficit of \$230,000 last year at this time. This is mainly due from not expensing the transfer to the Plant Fund. The College will evaluate this at the end of the year.

The annual plant fund budget most likely will be underspent at the end of the fiscal year. This is largely due to the delay of the K-wing renovation. The project was placed on hold until there is a determination whether our project will be considered for funding by the State.

In terms of a legislative update, as of now we have only heard the Governor's proposal.
