- CALL TO ORDER Board Chair K. Houston-Philpot called the meeting to order at 7:21 p.m.
- **APPROVAL OF AGENDA** E. Wacksman made a motion to approve the agenda with support from R. Stafford. Motion passed unanimously.
- **PUBLIC COMMENTS** Board Chair K. Houston-Philpot called for comments from the public.

Z. Kozicki introduced himself as one of the candidates that has put in an application for the position of Midland Trustee. He said that he was in attendance to observe the meeting.

- **TREASURER'S REPORT** D. Lutz informed the Board that at the end of April, the College remains in a solid cash financial position. Enrollments continue to exceed budget. As a result, tuition and fees are exceeding budget as well. In addition, due to the need to hire additional adjuncts to serve our students, the cost of part-time wages are exceeding budget. There are no other significant variances to report at this time.
- CONSENT AGENDA Board Chair K. Houston-Philpot called for approval of the consent agenda. R. Emrich made a motion to approve the consent agenda with support from K. Lawrence-Webster. Motion passed unanimously, approving the Minutes of the Board Dinner Meeting April 13, and the Board Regular Meeting April 13, 2010, as well as the Testing Center Relocation/Renovation Project Construction Contract (BA4816) and the purchase of an SMC Automated Manufacturing System (BA4817). As part of the consent agenda, the Board also approved the removal of Senate Policy 2.025, Copyright Materials, (BA4818) and Senate Policy 2.035, Drug-Free Workplace Act of 1988, (BA4819) from the Senate Handbook. In addition, the Board approved revisions to Senate Policy 5.020 (BA4820).
