CALL TO ORDER	Board Chair Emrich called the meeting to order at 7:06 p.m.
APPROVAL OF AGENDA	Board Chair Emrich called for approval of the agenda. The Board unanimously approved the agenda.
PUBLIC COMMENTS	Board Chair Emrich called for public comments. There were no public comments.
TREASURER'S REPORT	D. Lutz presented a mid-year budget update to the Board. She said that if we reach our projected credit hour goal for spring (30,000 credits) that we will make our target for 2011-12 (245,500 credit hours). She noted that we will have a variance in revenue due to the settlement of the MCV issue in Midland. Instructional salaries are expected to be over budget by \$600,000. Cost savings in the amount of approximately \$850,000 will be realized for the year due to a change in the way that we are funding our health insurance coverage. Overall, at this point, D. Lutz said that she anticipates that we will end the year with a positive variance of approximately \$1.3 million.
CONSENT AGENDA	Board Chair Emrich called for approval of the consent agenda. The Board unanimously approved the consent agenda, accepting the minutes of the Board Dinner Meeting and Regular Meeting that was held on January 17, 2012. Senate Policy 2.050 Leaves of Absence (BA4917), revisions to Senate Policy 2.090 Sabbatical Leaves and Grants (BA4918), revisions to Senate Policy 8.060 Academic Graduation Certification Requirements (BA4919), the rescission of Senate Policy 2.065 Judicial Process (BA4919a), and Senate Policy 2.076 Whistleblower (BA4920) were approved as part of the consent agenda.

ADMINISTRATIVE REPORTS

STUDENTDavid Redman, Mathematics Division Chair, gave a report on the Math³ program. The
goals of Math³ are success, persistence, and retention. Math³ is an immersive
experience that puts 30-45 students into the classroom with 2-3 faculty members as
well as an SLA. Math³ gives students the opportunity to complete the MTH 092, 096,
097 course sequence in 1 semester instead of 3.

David presented the results of the program to-date, noting that so far it has been a success.

Board Chair Emrich said that these are the types of programs that we should be telling our Senators and Representatives about. They reinforce the importance of the work that we are doing in community colleges.

PRESIDENT'SDr. Goodnow thanked Trustee Emrich, Trustee Selby, and Trustee Stafford for attending the ACCT**REPORT**Legislative Summit with her last week in Washington DC.

Mission Update

As part of her Board update this month, Dr. Goodnow sent a summary of the Student Success Summit that was held on January 27. She thanked Trustee Selby, Trustee Stafford, and Trustee Wacksman for attending.

One of the outcomes of the Summit was drafting a revised mission statement for the College.

A representative team of 14 faculty and staff members met on the Saturday following the Summit. Using all input from the attendees of Friday's Summit, 2 proposed versions of revised mission statements were developed. These revisions were sent out on the Delta-L for review and comment

by the entire College Community.

This past Friday, the 14 person writing team met to incorporate the feedback received and finalize a draft of the revised mission statement. Next steps for the mission are to share the draft with Strategic Planning Committee, the College Community, take the mission draft to the Senate, and of course, review by the Board of Trustees for final approval.
