**CALL TO ORDER** Board Chair R. Stafford called the meeting to order at 7:04 p.m.

APPROVAL OF AGENDA

Board Chair R. Stafford called for the approval of the agenda. R. E. Selby made a motion to approve the agenda with support from M. Rowley. The agenda was approved unanimously.

# PUBLIC COMMENTS

Mike McRoberts of Bay County said that he would like to hang a flag displaying the conservative family moral next to the LGBT flag that hangs in the LLIC. He said that when he asked to display the flag he was not allowed to do so. M. McRoberts said that he feels that his first amendment rights have been violated. He demanded that the Board of Trustees take action to allow him to post the flag or to "tear down" the LGBT flag that is hanging in the LLIC. M. McRoberts said, "You are my last stop, I exhausted all options and procrastination in this matter is not recommended."

- J. Goodnow asked M. McRoberts to explain what he meant by saying that he had exhausted all options. She asked where he had taken his request.
- M. McRoberts replied that he had asked the library staff and Student Engagement. He said that it has been three days since he called. I have yet to hear a word and all I was told was that I had to have approval to display images on the boards.
- J. Goodnow replied that she was not aware of the issue and said that the Administration will look into this.

Patrick Nitschky of Midland County and a member of IBEW Local 692, spoke about his ongoing concerns (regarding prevailing wage violations) with a contractor that has been hired to work on the Health Professions Building Project. He questioned whether or not the Board of Trustees has a policy in place regarding selection of contractors. P. Nitschky asked how the Board could be aware of the details of what they are approving when they approve so many items as part of the consent agenda.

Board Chair Stafford responded that the College has had a policy in place (regarding bidding and hiring of contractors) for 51 years. Jess Peil requested a copy of the minutes in which the Board of Trustees approved the Health Professions Building Renovation Project. R. Stafford said that a copy would be provided to him.

# TREASURER'S REPORT

D. Lutz said that the Board has received the financial reports for the month ending March 2013. The College is in good cash position. The financial statements reflect that we are now 75% of the way through the fiscal year. D. Lutz said that she has compared budget to actual. Other than the variances that have already been reported, the College is operating in accordance with the plan.

### CONSENT AGENDA

Board Chair Stafford called for approval of the consent agenda. K. Ellison asked that item C, Approval of Coffee n' More Expansion Project Budget and Bid Authorization, be removed from the consent agenda. E. The Trustee unanimously approved the amended consent agenda, approving the minutes of the March 12, 2013 dinner meeting and March 12, 2013, regular meeting of the Board of Trustees.

Based on the results of the promotion and tenure hearings, recommendations move from the Dean of Teaching and Learning to the Vice President of Instruction and Learning Services to the President for approval.

Dr. Goodnow said that she carefully reviews the packet of each faculty candidate before giving approval. She added that she continues to be proud of the packets that our faculty put together each year which demonstrate their dedication to students, teaching, and the college as a whole through their commitment to teaching effectiveness, educational and professional growth, and productive activity for the College other than instruction.

- As a reminder, the Outstanding Graduate Ceremony will take place on Tuesday, April 23

  that Commencement will take place on Friday, April 26. Hors d'oeuvres will be served in
  the Boardroom beginning at 4:30pm and the ceremony will begin at 6:00pm in the gym.
- Dr. Goodnow said that one of her goals is increasing dual enrollment at Delta College. We have been working with Birch Run Area Schools to develop an agreement to offer students the opportunity to earn an associate of arts degree while earning their high school diploma. As part of the agreement, a small cohort of students will attend college and high school classes together for a total for three academic years. These students will enroll in AP as well as college classes. They will attend the college classes in the newly renovated South Building at Birch Run High School. Upon completing the program, the students will have their high school diploma and an associate's degree from Delta College.

This is a very exciting opportunity for Delta College. Our accrediting body, the Higher Learning Commission, requires us to notify them of this program as an "additional location" for Delta College. Birch Run would be considered an "additional location" because the

# TRUSTEE COMMENTS

E. Wacksman said that she enjoyed Randy Crawford's art exhibit. Randy has a solo art exhibit at the Saginaw Art Museum. His show, ULTRABRICATION: The Art of Randal Crawford, will run March 29—May 10, 2013. She encouraged all to attend.

M. Rowley said that he is proud of the way that Delta College handles its business processes – including the bidding process. He asked if the level of detail (regarding items for approval) that is available to the Board is available to the public. J. Goodnow said that it is.

M. Rowley said that the recent gun violence debate was extremely well done. He said that he looks forward to attending debates in the future.

R. E. Selby gave an overview of the spring MCCA Board of Directors Meeting which was hosted by Wayne County Community College District. He said that much of the meeting agenda was spent addressing the issue of talent shortage in Michigan. He cited some model programs at WCCC, GRCC, and HFCC that have been developed to help address the shortage. - J. MacKenzie (speaking to P. Nitschky and J. Peil) said that the Board does understand where the College's dollars are going. We have policies in place and follow the rules and regulations.

Board Chair Stafford said that the meetings that really stand out to him are the meetings in which the Board has the opportunity to see the success our students have attained. He congratulated the students that were recognized as part of this meeting.
