This form will allow you to be considered only for a Federal Stafford **Unsubsidized** loan, with the maximum amount of \$2000 per academic year. **You must complete a [2009-2010 Federal Direct Stafford Loan Request Form](#) for loan consideration.** You will not be considered for any need-based financial aid. This form cannot be completed for a student who lives in the parent(s)' household, even if the student pays rent to the parent(s).
