Access Legal Periodicals in EBSCO or InfoTrac:

Go to:

EBSCO and use " Index to Legal Periodicals and Books " to search for information on legal topics in legal journals, law reviews, and also book review citations. Use this index to obtain citations and request the articles or books through interlibrary loan. This database requires an authorization number and password at off-campus locations.

Infotrac and use the database "LegalTrac" to search for legal topics in law reviews, bar journals, and legal newspapers. Some publications available full text online or use citations to request periodicals through interlibrary loan. This database requires an authorization number and password at off-camp.
