APPROVAL OF AGENDA Board Chair K. Houston-Philpot called for approval of the agenda. K. Higgs made a motion to

approve the agenda. R. Stafford seconded the motion. Motion passed unanimously.

PUBLIC COMMENTSBoard Chair K. Houston-Philpot called for comments from the public.

TREASURER'S REPORT D. Lutz informed the Board that at the end of October, the College remains in a solid cash

financial position. Enrollment is up resulting in a positive variance of 5,700 credit hours over projection. The College has received its first installment of State aid (in the amount of \$1.5

million). At this time there are no additional variances to report.

motion to approve the consent agenda. R. Stafford seconded the motion. Motion passed

unanimously.

K. Higgs made a motion to amend page 18, section VIII (Guidelines for Board Committees) in order for the language to match that of the Bylaws that were approved in October. R. Stafford

seconded the motion. Motion passed unanimously.

Approved by the Board of Trustees at the December 2009 Regular Meeting.

K. Higgs made a motion to amend page 16, section V (Delta College Board of Trustees Procedures for Grievance Appeals to the Board of Trustees) to reflect that only the person grieving may ask for a closed session. R. E. Selby seconded the motion. Motion passed unanimously.

K. Higgs made a motion to strike "nor do they criticize or work against board decisions," on page 4 of the proposed Operating Parameters. R. E. Selby seconded the motion. Motion passed unanimously.

The amended Operating Parameters were adopted by the Board of Trustees with a vote of 7 in favor, 0 opposed.

R. Stafford made a motion to approve the recommendation with support from R. E. Selby. Motion passed unanimously.

Roz Weedman has been reappointed as Chair of the English Division for a three-year term. Roz will begin her second term as Division Chair on May 1, 2010. Her term will end on April 30, 2013. More information about Roz as well as a full report of hires and separations is included in Board Packets.

PRESIDENT'S ANNOUNCEMENTS

- Registration for the winter semester began on Monday, October 26. As of today, 10,256 students have registered.
- Dr. Goodnow received a letter from the State Department of Treasury congratulating Delta College on its success in assisting student loan borrowers in avoiding student loan default. The letter notes that Delta College's cohort default rate has been below ten percent for the three most recent cohort years as published by the U.S. Department of Education.
- Delta College received some great coverage in the recent <u>Great Lakes Bay Region</u> publication. This regional publication is made possible through a cooperative effort of the Bay, Midland, and Saginaw Chambers.
- Dr. Goodnow provided the Board with an update on State and Federal Legislation.

Approved by the Board of Trustees at the December 2009 Regular Meeting.

Federal Legislation

While the big news in Washington continues to be health care, MCCA is closely watching what the Senate will do with the American Graduation Initiative. MCCA's top three concerns have been and continue to be:

- 1) That institutions, not just States, be allowed to apply for the second round of funding. Also, remove the requirement that the second round of money be used for "system" reform.
- 2) Reduce the match from 1:1 to something less. AACC is advocating something more like a 50% match. Even though the match can be "in kind," 100% match may be tough for many institutions.
- 3) Allow the capital construction funds to be used for direct funding, rather than just as match toward capital campaigns.

State Legislation

On November 5, 2009, the House Education Committee reported HB 4837 and HB 5533 – legislation that would authorize community colleges to confer certain baccalaureate degrees.

The bill now heads for consideration by the full House of Representatives. Introduced by Rep. John Walsh (R-Livonia) and Rep. Joel Sheltrown (D-West Branch), this bipartisan proposal focuses on four programs of study – nursing, culinary arts, concrete technology and maritime technology. Each one of these areas is proposed in response to specific industry demand not currently being met adequately by the State's higher education system.

Another bill that Michigan Community Colleges are paying close attention to is the firearms legislation. The first bill that was proposed prevented colleges and universities from regulating firearms on campus in a more restrictive manner than state law. A substitute bill has now been introduced.

The substitute bill prohibits an institution of higher education from enacting a policy that bans those licensed under the Concealed Pistol Licensing Act from possessing their licensed firearm in "any open area...that is available for use by the public, including, but not limited to, a sidewalk, parking lot, road or common area." Possession includes vehicle storage. The proposed section goes on to allow colleges to prohibit non-licensed individuals and employees (regardless of license), as well as allowing complete bans of firearms (regardless of license) in any campus building, structure, or area not available for public use.

On Thursday, Michigan Community Colleges will be participating in a conference call with Governor Granholm to discuss the Michigan Promise Grant Program. Trevor Kubatzke, Vice President of Student and Educational Services, will be representing Delta College.

TRUSTEE COMMENTS

K. Higgs requested that at the next meeting a tuition freeze for the 2010-11 school year be placed on the agenda.

R. E. Selby said that the Budget Cabinet should be allowed to complete their work. The realities that we are living in will provide them with direction for completing their work. R. E. Selby said Approved by the Board of Trustees at the December 2009

that Mr. Higgs' recommendation is premature. The College has no idea about what is going to happen in the State of Michigan. In addition, property tax revenue is declining.

K. Lawrence-Webster said that Board of Trustees Dinner Meetings need to be more focused. The discussions that take place at Dinner Meetings should more intentional and policy-focused.

K. Lawrence-Webster noted that she would like the Board to review its policies as they relate to Finance. Specifically, she talked about policies regarding the general fund balance as well as transfers from the general fund to the plant fund.

R. Stafford said that the Chocolate Affair was a wonderful event. He complimented Pam Clark and the Institutional Advancement Staff for a job well done.

There were no comments from the Chair.

ADJOURNMENT

There being no further business, Board Chair Houston-Philpot adjourned the meeting at 8:50 p.m.
