• The Harvey Randall Wickes Foundation of Saginaw recently donated \$725,000 to Delta College in support of a new Diesel Technician program.

The funding includes dollars for the purchase of tools, equipment, training and faculty certification. Over the past five years, the need for this program has strengthened, due to strong industries, an aging workforce and anticipated retirements of "Baby Boomers" (those aged 55+). In order to address the hiring gap that is and will be occurring, Delta College will now be launching this unique program, which has the potential of making a significant difference in the Great Lakes Bay Region – Bay, Midland and Saginaw Counties – and Michigan's Thumb and beyond.

The College sincerely appreciates the Wickes Foundation for making this program possible in this area.

The College's internal team – Mike Finelli, Tom Coats, Jennifer Carroll and Ginny Przygocki will be working to develop and finalize the curriculum for implementation as soon as possible.
