Dr. Goodnow delivered the following tribute in honor of outgoing Trustees, Kimberly Houston and Edith (Dee Dee) Wacksman:

"It is time to say thank you to two of our Trustees. It is with gratitude and, I have to be honest, sadness, that tonight we say farewell to two of our Trustees, Kimberly Houston and Dee Dee Wacksman.

I'm going to start by saying thank you to Kimberly Houston. Kimberly has been a Trustee representing Midland County since 2005. During her time on the Board, the Board has taken action on nearly 700 items – including the renovation of the Health Professions Building, and most recently, the new Saginaw Center.

Kimberly has been an advisor, a mentor, a thoughtful leader, and friend to me over the years. She is a wise thinker. I always look forward to her comments at the end of a Board meeting – as she eloquently summarizes the evening and provides us with her wisdom and reflections on our College.

Kimberly served as Board Chair for two years from 2009-2010. As Board Chair, she engaged the Board in professional development, made sure that all Trustee voices were heard, and encouraged us to engage in policy governance and policy thinking. She has also served on several Board Committees over the years and served as the alternate representative for the MCCA Board of Directors.

Kimberly recognizes the importance of Trustee Development and regularly attended conferences and workshops through MCCA and ACCT to learn more about community colleges and about being an effective member of the board.

Most recently, Dee Dee volunteered for our Democracy Commitment initiative to register voters on campus.

Dee Dee has also been an active participant in professional development. In addition to attending conferences such as MCCA and ACCT, Dee Dee has been a member of our AQIP accreditation Strategy Forum team on two separate occasions.

She truly values Delta College and the people who work here. A couple of years ago, she made a motion to reserve a parking spot for me. This may seem like a little thing to you – but it is a big thing to me. She recognized the fact that I have a tight schedule with meetings both on and off campus. She recognized how much easier that a parking spot would make it for me to get where I needed to go – and I appreciate that.

Dee Dee, thank you for leadership and your contributions to the Delta College Board and to our College as a whole. I appreciate everything that you have contributed over the years. We will miss you."
