TREASURER'S REPORT	D. Lutz said that the Board has received the College financial statements for the month ended June 30, 2017. The fiscal year has ended but the books are not final yet. The College is in a strong cash position. State funding is higher than expected due to the methodology that was used for personal property tax reimbursement to Colleges. In addition, the College had wage and benefit dollars that were budgeted, but not spent due to vacancies. In addition, the College came in under budget in its self-funded medical insurance expenses. The College ended the year "in the black" and in a favorable financial position. The final numbers will be presented in November.

- Dr. Goodnow said that she was saddened to learn of the passing of Dr. John Fuller, former Delta College Registrar and Chair of the College's Board of Trustees. Dr. Fuller remained committed to Delta throughout most of his professional life, retiring in 1988 after serving as Registrar since 1970. He served on the Delta College Board of Trustees from 1989 to 2000, filling the roles of Chair and Vice Chair during his tenure. He and his wife, Joanne, also established the Dr. John and Joanne Fuller Scholarship Endowment at Delta College. As Delta's Registrar, he worked hard to modify, upgrade and improve the College's registration and permanent record systems. He served as Senate President in 1973 and received the Don Laughner Award for Creative Change, which is awarded to an employee who makes "contributions that result in significant change in the institution," in 1988.
- Dr. Goodnow shared that Dr. Reva Curry, our Vice President of Instruction and Learning Services, has been nominated and elected to the Michigan Ace Women's Network Board of Directors for a three-year term for her leadership, talents, experience, and expertise.
- Dr. Crystal Starkey, English Associate Professor and PTK Advisor received the Paragon Award for New Advisors from Phi Theta Kappa. She was recognized for her efforts in increasing membership of our local chapter, mentoring individual members in their personal growth, and for her encouragement for the chapter to volunteer for events both on and off campus. Congratulations Dr. Starkey!
