- CALL TO ORDER** Board Chair Emrich called the meeting to order at 7:00 p.m.
- APPROVAL OF AGENDA** Board Chair Emrich called for approval of the agenda. D. Middleton made a motion to approve the agenda. M. Nash seconded the motion. Motion passed unanimously.
- PUBLIC COMMENT** Board Chair Emrich called for public comment.
- TREASURER’S REPORT** S. DuFresne, reporting in D. Lutz’s absence, said that the Board has received the College financial statements for the month ended August 31, 2017. S. DuFresne said that she has reviewed the statements and, as the fiscal year begins, the expenditures are in line with the budget. At this time, she has no variances to report.
- CONSENT AGENDA** R. Emrich called for approval of the consent agenda. M. Rowley made a motion to approve the consent agenda with support from R. E. Selby. The motion passed unanimously resulting in:

- BOARD ACTION STRATEGIC VALUES REPORT (BA5192)** It is the recommendation of the administration that the Delta College Board of Trustees certify to the State Budget Director that Delta College has met all 5 of the best practices listed in each of the categories required through Public Act Number 108 of 2017, Section 230 (3), thus exceeding the legislative requirements.

Motion passed unanimously.

J. Goodnow highlighted some of the key activities that were included in the report, noting that the report provides more than 13 pages of various activities and initiatives that illustrate how Delta College is meeting the best practices.

**BOARD ACTION
(BA5193)**

It is the recommendation of the administration that the Board of Trustees approve the purchase of the replacement of the two-way radio communication system to Anderson Radio, under the State of Michigan contract, in the amount of \$157,472.

R. E. Selby made a motion to approve the recommendation with support from M. Nash.

Motion passed unanimously.

CUBA TRIP**

Dr. Curry introduced Felicia Peters, Professor of Computer Science, and Crystal McMorris, Assistant Professor of English.

F. Peters and C. McMorris presented photographs and information about the Cuba Trip that they led in March of 2017. Students, faculty, and community members went on the trip to learn about the history, culture, and people of Cuba.

They spoke about a Delta College student, Benecia Garcia, who was positively impacted by the trip. As a result of her involvement in this travel abroad experience, B. Garcia has made the decision to engage in additional travel abroad experiences. In addition, she has changed her major to international business.

**PRESIDENT’S REPORT
DISCUSSION OF
PRESIDENT’S GOALS**

Board Chair Emrich opened the discussion of the President’s draft goals for 2017-18. He noted that the Trustees received the goals for review last month. The purpose of this discussion is to provide the President with feedback.

D. Middleton said that she would like to comment on the goal regarding the “sustainability of the College’s go-forward operating model.” She said that serving on the Budget Cabinet has made her even more aware of the importance of looking at the expense side of our operations. For example, how do we right-size our course offerings? How do we ensure that those offerings meet the needs of our student body?

R. Emrich echoed D. Middleton’s comments. He said that we cannot continue to cut to balance the budget. As a College, we have to change the way we do things. The College needs to examine the size of its faculty and staff, its culture, class size, when we offer,

where we offer, etc. He noted that if the College doesn't change, it won't be around in the future.

K. Lawrence-Webster asked where the Board fits in when it comes to changing the culture.

R. Emrich said that the Board will be involved in the discussions and will hear the recommendations that the Administration brings back. The College must examine the number of services and how things can be changed without "losing our soul." He said that the Board is open to hearing from everybody at the College regarding ideas for moving forward.

K. Lawrence-Webster said that while the College does a thorough job of making projections that are 2 years out, but years 3, 4, and 5 become stagnant.

R. Emrich said that as the cost of higher education continues to rise, the College needs to leverage the fact that Delta College is a very affordable, high quality education for the first two years.

M. Rowley said that the Board can be part of the solution or part of the problem. He said that he is ready to be part of the solution.

J. Goodnow thanked the Board for the feedback. She asked that any further feedback be sent to her as soon as possible. She said that she will bring the final goals to the Board for approval in October.

Enrollment Report

Classes for the Fall 2017 Semester began on August 26. As of today, 8,691 students have registered (5,546 part-time, 3,145 full-time).

The College projected 80,918 credit hours for the fall semester and is currently at 97.05% (78,531.9 credit hours) of projection.

- Dr. Goodnow encouraged the Trustees to take a look at this month's Fantastic Faculty which has been uploaded to BoardBook.
- Board folders have been updated to reflect the College's Fall 2017 numbers. Dr. Goodnow pointed out that the ratio of our credit hours being taught by full-time, in comparison to part-time, is 69%/31% respectively. Senate Policy specifies that as a College we will strive for 65%/35%.

M. Rowley mentioned that last month the President shared a letter that the College received from the Bay Veterans Foundation regarding the informational kiosk in Battery Park. M. Rowley mentioned that he visited Battery Park and that this is a wonderful project. He also noted that Tom Friewald, who was a faculty member at Delta College for more than 30 years, had drawn the blueprints for the project. He noted that even in retirement, Mr. Friewald is still serving our community.
