#### BOARD ACTION ROADWAY LIGHTING UPGRADES ON MAIN CAMPUS (BA5219)

BOARD ACTION APPROVAL OF FACULTY SALARY AGREEMENT (THREE FISCAL YEARS ENDING 2019-2021) (BA5221) B. Webb said that it is the recommendation of the Administration that the Board of Trustees approve the Faculty Salary Agreement for the three fiscal years ending 2019-2021 which was ratified by faculty on April 6, 2018 and includes salary schedule increases to base only of 2.0%, 2.2% and 2.3% respectively, benefit design changes including an increase to the emergency room visit to a \$250 co-pay, a five (5) tier prescription plan co-pay, an increase in the first dollar deductible to \$500/\$1000, an optional HSA and an optional online/telehealth service.

- R. E. Selby made a motion to approve the recommendation. M. Benecke seconded the motion.
- R. E. Selby said that while he intends to vote in support of the motion, unfortunately, this contract just "kicks the can down the road." There are systemic problems at this institution that this contract (and its provisions) does not address. He noted issues including class sizes and declining enrollments.
- R. Emrich said that he agrees and expects that the Board will see specific recommendations from the Administration within the next 6 months. R. E. Selby stated that he would expect action in a month.
- M. Nash noted that the "go forward operating model" for the institution is part of the President's goals and said he expects this issue will be addressed as part of the goals and evaluation process.

The motion to approve the Faculty Salary Agreement passed unanimously.
