- **TREASURER'S REPORT**S. DuFresne said the Board has received the financials for the month ended October 31,
2018. The College started receiving State Aid payments from the State of Michigan in
October. She said that she has reviewed the financials. Tuition revenue is less than
expected. At this time she has no additional variances to report.

PRESIDENT'S REPORT <u>Enrollment Report</u>

The Fall Semester began on August 25. As of count date, 8,080 students are enrolled (5,231 part-time, 2,849 full-time).

The College projected 75,495 credit hours for the fall semester and as of count date we are at 96.52% of projection.

Winter 2019 registration is underway. As of today, 4,562 students are registered.

The College projected 69,903 credit hours for the winter semester and are currently at 82.90% (57,946.5 credits hours) of projection. Winter semester begins on January 5, 2019.

Information Sharing

- October 19, Senator Gary Peters visited the campus to talk with administrators to learn more about our tech and skilled trade programs and the partnerships Delta College has with area businesses. After the discussion, he toured the skilled trades and health professions areas. Dr. Goodnow thanked all who assisted with his visit, especially Pam Clark, Martha Crawmer, Ginny Przygocki, Kara Reder, Harvey Schneider, and Terry Morse.
- The Delta College Foundation held its "Chocolate Affair" event on November 1st at the Valley Plaza in Midland. The Foundation Office is still assembling all of the financial information, but from the tickets turned in at the door, we had nearly 550 people who attended the event. Of course, all of the proceeds support our Possible Dream program. Dr. Goodnow said she was pleased that 7 of our 9 elected Trustees were able to join us at the event. It was a great evening with our community supporters!
- Congratulations to the Lady Pioneers Soccer Team who placed second in the NJCAA Division 3 National Championship tournament held this past weekend in Rockford, Illinois. As you may recall, last year they placed third. Three of our players made the All-Tournament Team – Kalyn Breckenridge, Kyla Breckenridge, and Hope Emington.
- The Higher Learning Commission will be conducting a multi-location site visit tomorrow of the Midland Center and the Saginaw Correctional Facility. HLC Reviewer, Dr. Roberta Teahen, will interview faculty and staff to review the academic offerings and services at the Midland Center and the correctional facility. Dr. Reva Curry, Dr. Martha Crawmer, and Ginny Przygocki will be participating in this one-day site visit.
- The Bay City Chapter of the NAACP is holding their annual Freedom Fund Banquet on Sunday, November 18. The theme for the event is, "Solidarity, Now More Than Ever!" The keynote speaker is Lecia Brooks, Outreach Director at the Southern

- Dr. Goodnow said that the College is working on the go-forward operating model for organizational sustainability.

Following the Administration's presentation in June, the Board requested that the Administration provide a monthly update on the work the College is doing.

This evening, Dr. Goodnow asked Ginny Przygocki to provide a brief update on our new program development including our medical assisting program.

G. Przygocki said that in the past year there have been 623 curriculum proposals. The majority are improvements to courses, but 54 of these proposals have been program-related. Three new programs have moved through the curriculum process this year including:

- Clinical Medical Assistant
- Instrumentation Technician
- Sterile Processing Technician
- Dr. Goodnow wished a Happy Birthday to Mike Rowley (Thursday, November 15) and also wished him and his fiancée, Tracy, the best as they exchange vows next weekend.

TRUSTEE COMMENTS K. Lawrence-Webster said that she attended the MCCA Fall Trustee Institute and feels the Board should help determine the culture of the College. She said that there are different

types of governance that were discussed at the meeting. She noted that the Board and College need to determine what model we are going to follow.

M. Benecke said she also attended the MCCA Fall Trustee Institute and feels transparency of the governing model is important to determine how we are going to work together. She suggested strategic planning as a Board. M. Benecke said that she would like to have information about curriculum for the new Saginaw Center soon.

M. Nash said that it was encouraging to see progress on the curriculum development of new programs to be offered. He noted concern for the recent trend in tuition increases -- 8 percent, 7 percent and 6 percent in the last three years -- being greater than 2x GDP over that same time period. The tuition increases have been Delta's way to make up for enrollment declines. He said that he is very concerned about affordability remaining Delta's hallmark as a community college. He feels there is a reluctance across campus to change. Delta College is at a crossroads and needs significant action to make real cost structure changes.

M. Rowley supported Mike Nash's comments. He said that Michigan State University adopted a flat rate tuition structure. M. Rowley expressed the need for the College to be open to different ideas.

CHAIRS COMMENTS Board Chair Emrich disagreed (with M. Nash) that the College hasn't done anything to change. The directive of the Board to implement the go-forward operating model was significant and has caused anxiety about shared governance. There needs to be clarity about what shared governance means. The College can't take a year to change policy. The Board is the final arbiter of policy. The Board continues to support the President in making the changes necessary to get costs under control.

R. Earl Selby passed away last week. Board Chair Emrich said that he and Earl served on the Board together for many years and that he lost a dear friend. A gathering in Earl's memory will take place on December 1 at Bethel AME Church.

Board Chair Emrich said that he attended the Association of Community College Trustees (ACCT) National Leadership Congress this past month. He said that he believes the Board needs to evaluate themselves and develop succession procedures.

Board Chair Emrich congratulated newly elected Board of Trustee members Marcia Thomas and Stacey Gannon. He thanked Kelley Peatross for her service.

ADJOURNMENT There being no further business, Board Chair Emrich adjourned the meeting at 8:42 p.m.
