CALL TO ORDER

Board Chair, D. Middleton, called the meeting to order at 7:06 p.m.

APPROVAL OF AGENDA

Board Chair, D. Middleton, called for approval of the agenda.

M. Benecke made a motion to approve the agenda. M. Thomas seconded the motion.

The Board voted unanimously to approve the agenda.

PUBLIC COMMENTS

Board Chair, D. Middleton, called for public comment.

Dan Sabourin, faculty member in the Health and Wellness Division and FEC Co-chair, spoke about the voluntary employee severance plan that is being presented by the administration for Board approval this evening. He said that when President Goodnow shared this plan both he and Daisy McQuiston were very pleased. This plan is fantastic and he said he hopes the Board approves it this evening.

TREASURER'S REPORT

S. DuFresne said the Board has received the financials for the month ended January 31, 2019. She said that she has reviewed the financials and the College is in a strong cash position. S. DuFresne said she has compared the statements to budget and to prior years. At this time, she has no additional variances to report.

BOARD ACTION

Surveillance Cameras and Door Access Control (DAC) – Parking Lot Cameras (BA5272) It is the recommendation of the administration that the total "Cameras and Door Access Control- Infrastructure" project budget of \$320,000 be approved authorizing the Facilities Department and administration to award contracts to complete the project.

BOARD ACTION

Voluntary Employee Severance Plan (BA5273) It is the recommendation of the administration that the Board of Trustees approve Delta College to offer a Voluntary Employee Severance Plan as presented and outlined in the Board Resolution which is titled "Delta College Board of Trustees Resolution ESP-Employee Service Plan, and approve as presented the related ESP Plan Agreement Document titled "Delta College 2018-2019 ESP-Employee Severance Plan" inclusive of Exhibits A, B, C, D, E, & F, as presented.

R. Emrich made a motion to approve the recommendation. M. Benecke seconded the motion.

Dr. Goodnow welcomed Merry Kelly and Katy Rose from EPC. EPC is the firm that would be administering the voluntary employee severance plan.

K. Rose said that she has enjoyed working with Delta College's administration. She noted that the administration has done due diligence in working with EPC on this plan. K. Rose provided an overview of the work that EPC does to support organizations in implementing voluntary severance plans to support the long-term financial sustainability of the institutions it serves.

She provided an overview of the plan that is being proposed for Delta's full-time faculty, facilities, food services, administrative professional and support staff. The eligibility requirement of 10 years of full-time service to the College captures those who are at the top of the pay scale.

Each eligible employee will receive a customized booklet that will help them understand the benefit and how it will impact them in retirement.

In addition, EPC will host a general meeting as well as customized counseling sessions with each eligible employee to ensure that employees are as informed as possible about this benefit. K. Rose said that EPC always encourages those eligible to consult with external financial advisors and tax experts about this plan as well.

K. Lawrence-Webster said that she was planning to vote no on the plan because she doesn't believe they work in the long-term.

D. Middleton called the question. The results of the vote were 7 in favor, 1 opposed. K. Lawrence-Webster voted in opposition.

STUDENT SUCCESS REPORT

Developmental Education and the Delta Difference Dr. Martha Crawmer introduced Kristin Cornelius, Associate Professor of English.

Kristin provided an overview of developmental education at Delta College. She said that four out of ten students at Delta College need at least one developmental course (in reading, writing, or math). One in four students need developmental courses in all three areas.

Kristin presented success rates of students in developmental education. She also presented success stories of several students at the College who have moved through the developmental sequence and gone on to successful careers, 4-year colleges and universities, and graduate school.

K. Lawrence-Webster asked about the cost of developmental education. J. Goodnow said that unlike other colleges, at Delta our faculty teach both developmental and college-level courses. We do not have a separate department for developmental education.

M. Rowley thanked the faculty for their passion and energy. He asked if there has been any talk of mainstreaming our students into college-level courses which is a trend he has heard about at other community colleges.

Kristin and Nate Blecke, Professor of Mathematics, reviewed options for students to earn college credit with extra hours of instruction.
