**CALL TO ORDER** 

Board Chair, D. Middleton, called the meeting to order at 7:00 p.m.

**APPROVAL OF AGENDA** 

Board Chair, D. Middleton, called for approval of the agenda.

M. Benecke made a motion to approve the agenda. S. Gannon seconded the motion.

The Board voted unanimously to approve the agenda.

**PUBLIC COMMENTS** 

Board Chair, D. Middleton, called for public comment.

TREASURER'S REPORT

- S. DuFresne said the Board has received the financials for the month ended June 30, 2019. She said that not all adjustments have been made but preliminaries are underway for closing the books for the 2018-2019 academic year.
- S. DuFresne reported that the College was able to cover the expenses for the Voluntary Employee Severance Plan with dollars from the general fund (instead of utilizing reserves) and said she is confident that the ending fund balance will be at a minimum of 10%.

# 1. June 4, 2019, Special Meeting

#### **STUDENT SUCCESS**

Margaret Mosqueda, Vice President of Student and Educational Services, introduced Jonathan Miller, Dean of Students.

Jonathan talked about Welcome Days which will take place for new students on August 15, 17, and 19.

Welcome Days will offer new student opportunities for engagement and information on their programs. He presented an outline of each day. The program will include a faculty panel, a Title IX presentation, breakout sessions, and introductions of Student and Civic Engagement Staff.

In addition, Jonathan presented Welcome Week student engagement events that will be held at main campus and the Downtown Saginaw Center.

He said the Student Engagement Office will be working to expand the events to other centers in upcoming years.

#### **PRESIDENT'S REPORT**

Registration is underway for the Fall 2019 Semester. To-date, 7,362 students have registered.

We projected 79,368 contact hours for the fall semester and are currently at 99.22% (78,748 contact hours) of projection.

Fall classes begin on August 24.

# Personnel Report

The complete report of hires, promotions, and separations for the months of June and July can be found in Board packets this evening.

#### Information Sharing

- Dr. Goodnow asked if there were any questions from the Board regarding the memo that was included in packets on the West Campus Project which includes the Delta College Observatory.
  - D. Middleton stated that the overall budget for the West Campus Project remains the same but the items that will most directly benefit students have been prioritized.
  - R. Emrich said that he is glad the President and the Administration changed their mind to support students.
  - M. Rowley said he appreciates the re-prioritization of the projects but he does not agree with the methodology and thinks that the project and budget should be modified by Board Action.

# CHANGES TO THE WEST CAMPUS PROJECT (BA5295)

- R. Emrich made a motion to support the changes to the West Campus Project as presented by President Goodnow. M. Nash seconded the motion.
- M. Nash said he agreed with M. Rowley's thoughts on policy and process.
- S. Gannon said that she very enthusiastically supports this project but also agrees that the Board should take action on such matters.
- M. Benecke said that she would like the record to show that the President discussed this matter with the Board Chair, Vice Chair, and Past Chair. Support was provided to bring forward using this methodology of an informational memo to inform the Board of the reprioritization of the budget dollars to the full Board by that group. The President did not make this decision without their guidance.

The motion to support the changes to the West Campus Project passed unanimously.

The College has two NEW 3+1 Articulation Agreements for Delta's Associate of Applied Science (AAS) in Nursing to the Bachelor of Science in Nursing (BSN) degree. The agreements are with <u>Central Michigan University</u>, Herbert H. and Grace A. Dow College of Health Medicine and <u>Oakland University</u>, School of Nursing.

The Bachelor of Science in Nursing program is designed to provide a natural transition from the Associate's degree to the Baccalaureate level completion program. Students must have an Associate's degree in Nursing to be admitted into either program.

Both BSN programs are delivered completely online and accept 100/200 level courses as a transfer equivalent.

# Benefits of the CMU program:

- Up to 90 Delta credits will transfer and apply.
- Only 30 credits needed to complete the BSN.
- Students can start the BSN program and take up to 12 credits while preparing for the NCLEX-RN exam.

# Benefits of the Oakland program:

- Up to 93 credits will transfer and apply.
- Only 32 credits remaining for completion.
- Special price of \$9,995 to complete the 32 BSN credits.
- No fees.

New Articulation Agreements will have an annual administrative review and renew in five years.

Delta College has been selected to join the first cohort of colleges participating in this year's Caring Campus which is an initiative of the Institute for Evidence-Based Change, with support from Ascendium Education Philanthropies. Coaches instruct professional staff on the fundamentals of what can be done to increase student connectedness to the college. This initiative will be integrated as part of the Delta

- College Strategic Plan as it relates to activities that positively impact retention of enrolled students.
- The Downtown Saginaw Center Open House and Dedication was a huge success. Dr. Goodnow thanked all the Trustees that were in attendance for this historical event. Dr. Goodnow also acknowledged all of the individuals at the College that played a role in planning and implementing this incredible event.
- In a Board update, Dr. Goodnow included a letter from Dr. Water G. Bumphus, President and CEO of the American Association of Community Colleges congratulating Delta College on the publication of *Journeys*, under Pam Clark's leadership. Dr. Goodnow thanked all of the individuals in our Marketing and Public Relations Department for their excellent work in researching, writing, and publishing *Journeys*. She also thanked those in Institutional Advancement and our Foundation Office who work tirelessly to plan fundraising events and keep meticulous records for all donations.
- 129 people enjoyed viewing Bay City's largest fireworks display from the planetariums' rooftop observation deck on July 6. As part of this fundraising event, participants also get to use our parking lot, and watched "First on the Moon," celebrating the 50<sup>th</sup> anniversary of the Apollo 11 moon landing. Planetarium Manager Mike Murray does an excellent job of promoting and planning this event.
- Lynn Hoerauf, our new Possible Dream Program Director, held several camps the past two months for our Possible Dreams students that focused on science, food, 3-dimensional art, and astronomy. A total of 58 students from Bay, Midland, and Saginaw counties ranging from grades five through eight have been inducted into the Possible Dream Program.
- Janis Kendziorski, Associate Professor in Accounting and four Delta students attended the Citizens' Climate Lobby Conference in Washington, D.C. held in the early part of June.
- There have been numerous events over the summer that faculty and staff have attended to promote the College:

     D.E.A.R. (Drop Everything and Read) at the Saginaw Children's Zoo was sponsored by the READ Association of Saginaw County. It is a great program to keep literacy skills active and ready for the next school year.
  - Great Lakes Bay Pride Event on June 29 Approximately 150 people visited Delta's table.
  - Friday Night Live in Saginaw on July 26 Monica Hernandez-Alaniz,
     Associate Counselor, and Cynthia Reyes, Admissions Representative, had
     the opportunity to be on stage several times that evening to promote Delta
     and our programs. Prospective students scheduled appointments to visit
     the new Downtown Saginaw Center.
  - 1<sup>st</sup> Annual Block Party Community in Saginaw on July 27 Admissions staff members attended and spoke with individuals interested in taking classes at the Downtown Saginaw Center.

She congratulated the astronomy faculty on their presentation and the observatory.

She congratulated Ron Sharp who won an MCCA award for being an outstanding educator. She also congratulated Nick Bovid and Sarah DuFresne as graduates for the 2018-19 MCCA Leadership Academy.

Chair Middleton said she read a recent article regarding Open Education Resources in the MCCA newsletter. Statewide savings to community college students this summer was \$1.2 million.

She noted the extensive list of retirements in this month's personnel report noting the years of service that employees dedicated to the College.

Chair Middleton congratulated Talisa Brown on her recent promotion.
