**CALL TO ORDER** 

Board Chair, D. Middleton, called the meeting to order at 7:10 p.m.

APPROVAL OF THE AGENDA

Board Chair, D. Middleton, called for approval of the agenda. R. Emrich made a motion to approve the agenda. M. Thomas seconded the motion.

Motion passed unanimously.

Board Chair, D. Middleton, called for public comment.

TREASURER'S REPORT

S. DuFresne said the Board has received the financials for the month ended January 31, 2020. The College is in a strong cash position and is operating in accordance with budget. She said she has no new variances to report. She added that budget development for the 2020-2021 fiscal year is underway.

**CONSENT AGENDA** 

D. Middleton called for approval of the consent agenda. R. Emrich made a motion to approve the consent agenda with support from M. Rowley. The motion passed unanimously resulting in:

BOARD ACTION Amending Meeting Minutes (BA5313) M. Rowley made a motion to amend the minutes from the January 12, 2016, Regular Meeting to Correct a Typographical Error of a Case Number. R. Emrich seconded the motion.

R. Emrich asked the Board Secretary why the Board was taking this action. A. Ursuy stated that last month, the Board amended minutes from four meetings to add specific

pending litigation. She stated that a typographical error was discovered on the case number for the January 12, 2016 meeting. This action is to correct that error.

#### **BOARD ACTION**

Approval of Facilities Condition Assessment Services (BA5314) It is the recommendation of the Administration that approval be given to award a contract for a Facilities Condition Assessment to DiClemente Siegel Design of Southfield, Michigan for the amount of \$135,726.

R. Emrich made a motion to approve the recommendation. M. Thomas seconded the motion.

Motion passed unanimously.

### **BOARD ACTION**

Bylaws Revisions, First Reading (BA5315) M. Rowley, Chair of the Bylaws Committee, said that two meetings of the Bylaws Committee have taken place. One was on Monday, January 27, and the second was on Tuesday, February 4, at 5:00 p.m. He said it is the recommendation of the Delta College Board of Trustees Bylaws Committee that the Board of Trustees accept the First Reading of the proposed revisions to the Delta College Board of Trustees Bylaws.

R. Emrich made a motion to approve the recommendation. M. Rowley seconded the motion.

R. Emrich clarified that the majority of the changes being proposed are to remove statements that restate provisions from laws such as FOIA, Open Meetings Act, and the Community College Act. The Board follows those laws and it is not necessary to restate them in the Bylaws.

Motion passed unanimously.

**GEO Science** 

Dean Martha Crawmer introduced Wendy Baker and Andrea Bair.

GEO Science was given by Andrea Bair, Assistant Professor of Geography, and Wendy Baker, Professor of Biology. They discussed the SAGE 2YC grant-funded project in which they're participating. The project's goal is supporting and advancing geoscience education in two-year colleges.

They shared positive results of how the teaching strategies they are employing impact student success.

Dr. Goodnow said she is extremely impressed with the data and results of this work.

M. Nash asked about scaling this work and taking it to other divisions. A. Bair said that she had the opportunity to share across disciplines at Winter Learning Day.

- Congratulations to Ginny Przygocki, Dean of Career Education and Learning Partnerships; David Baker, Professor of Chemistry; and Terry Morse, Associate Professor of Computer Numerical Control. All three are recipients of the League Excellence Award. They will be recognized at the League for Innovation in the Community College's Innovations Conference taking place at the beginning of March in Seattle. The excellence awards, previously called the John and Suanne Roueche Excellence Awards, recognize faculty and staff who exemplify exceptional teaching and leadership.
- Again, congratulations to all the recipients of the Endowed Teaching Chair Awards who were recognized as part the Winter Learning Day activities on January 24. The names of the recipients are listed in the President's Update to the Board included in Board Folders.
- Jim Lucas, nationally acclaimed actor, will be speaking on Wednesday, February 19, as part of the President's Speaker Series.
