CALL TO ORDER Board Chair Thomas called the meeting to order at 7:00 p.m.

TREASURER'S **REPORT**

AGENDA

S. DuFresne said that the Treasurer's report presented is for the month ended January 31, 2023. All funds of the College have been reviewed. She said she does not have any significant variances to report.

The 2023-2024 College Budget development process is underway. Administration and department leaders are working on developing a budget for next year.

The Budget Cabinet is planning to have a tuition and fee recommendation to present to the President by next week. Following President Gavin's review and approval, the recommendation will be presented to the Board for consideration at

the March Board of Trustees meeting.

APPROVAL OF PLANETARIUM ROOF REPLACEMENT (BA5477)

It is the recommendation of the Administration that the Board of Trustees approve the Planetarium roof replacement and authorize the Administration to award contracts to Mid-Michigan Roofing in the amount of \$664,386.

- D. Middleton made a motion to approve the recommendation. A. Clark seconded the motion.
- M. Wood asked about the lifespan of the roof. S. Gregory responded that it has a 20-year guarantee.
- B. Handley-Miller asked about the use of solar in the future. S. Gregory said that the College considers the impact of each project on our carbon footprint. Solar panels would not be an option for this roof because of the unique building and the use of the roof. S. Gregory said solar could be considered if the College chose to cover the parking lot in the future.

Motion passed unanimously.

DELTA COLLEGE CAMPUS PLANNING PRESENTATION

- Dr. Gavin gave a presentation on campus planning. He discussed the need for: 1) a comprehensive space usage analysis, 2) a space for student CARES resources, and 3) developing a new signage system.
- Dr. Gavin discussed how the campus planning work aligns with the goals of our strategic plan that will be brought forward at the March meeting for Board approval. As a College, we are primarily here to support students in achieving successful transfer to a 4-year institution or in entering the workforce.
- Dr. Gavin noted that community colleges were built on the concept of access to education. We now must pivot to retention and completion.

Doing so begins with creating a welcoming environment for all students. That environment can be created through spaces, services, and support.

- B. Handley-Miller said she is supportive of this work. She noted the placemaking work that set the foundation for this work. In addition, she suggested thinking of additional student needs such as charging stations and bus-stop waiting spaces.
- M. Nash mentioned that we need to think about creating a sense of belonging for our online students as well.
- D. Middleton suggested looking at our outdoor spaces as part of this work.

Dr. Gavin noted that the hardest part of college should be in the classroom. In the coming months, the Trustees will be asked to approve a proposal to support the campus planning process.

Enrollment Report

The winter semester began on January 7. As of this morning, 7,066 students are registered. We projected 67,211 contact hours for the winter semester and are currently at 103%.

• The State of Michigan Department of Labor and Economic Opportunity (LEO) recently announced grant funding awards to upskill employees in technical training through the use of Going Pro Talent fund. Many regional businesses received support. We are pleased to share that over \$260,000 in industry training will be delivered by Delta College Corporate Services to these businesses in the coming year. Training includes topics such as lean,

- Thanks to all who participated in MLK events at the Dow Events Center on January 16 and at SVSU on January 18. Both were exceptional events.
- Winter Learning Day was held on Friday, January 20. The student panel featuring Natasha Gargin and Brittani Thornton was a highpoint.
- Dr. Gavin took part in his first Aspen Institute Presidents Fellowship session in January. The session focused on ensuring institutions meet their stated missions of supporting students to transfer cleanly to their chosen majors or find well-paying jobs upon completion. Dr. Gavin said his "take away" was that Delta is on the right track. Our strategic plan makes it clear that this is our priority.
- In the next year, Dr. Gavin will take part in a few national panels regarding book banning. Additionally, he said he was honored to learn about recognition he will be receiving from the Phi Theta Kappa Honor Society.
- Lt. Governor Garlin Gilchrist II visited Delta's main campus on February 2 to promote the Michigan Reconnect scholarship. He visited with Terry Morse in the CNC lab, with Jim Proctor in the Welding lab and spoke with about 12 students who use the scholarship to attend Delta. The visit ended with an interview by Darold Newton, host of Delta Public Media's "Soul Issue" program. Thanks to Pam Clark and her staff for planning and organizing the event.
- Marcia Thomas, Diane Middleton, Michael Wood, Pam Clark and Dr. Gavin represented Delta College at the ACCT National Legislative Summit earlier this month. They had the opportunity to learn about national programs and meet with several of our local legislators.
- A delegation of nine faculty and staff traveled to San Antonio College to observe how this acclaimed community college's culture supports students outside of the classroom.
- Another group of 10 faculty and staff are currently attending the Achieving the Dream Conference in Chicago, IL.
- Dr. Gavin encouraged the Trustees to read the latest edition of the Delta Collegiate. There are several outstanding articles.
