<b>CALL TO ORDER</b>	Board Vice Chair Baldwin called the meeting to order at 7:00 p.m.
<b>APPROVAL OF THE AGENDA</b>	<p>Board Vice Chair Baldwin asked for a motion to approve the agenda.</p> <p>M. Nash made a motion to approve the agenda. M. Rowley seconded the motion.</p> <p>Motion passed unanimously.</p>
<b>PUBLIC COMMENT</b>	<p>Board Vice Chair Baldwin called for public comment.</p> <p>Richard Luczak, Bay City made comments on an article that appeared in Truthout on DEI programs and Dr. Gavin.</p>
<b>TREASURER’S REPORT</b>	<p>G. Luczak said that the Board has received the College financial statements as of March 31, 2025.</p> <p>State appropriations and property tax revenues are in line with our projections and budgets.</p> <p>Tuition and fees revenues will exceed our budget projections. Spring enrollment is still taking place, but it is looking like we will come in around 194,000 contact hours. This is 20,000 more contact hours than our budget of 174,000.</p> <p>Investment income is on track to meet our budget amount.</p> <p>The combined auxiliary funds reflect a deficit of \$18,000 versus a positive balance of \$43,000 last year. Food Services continues to struggle but is seeing an uptick in business.</p> <p>Facilities has been knocking out projects recorded in the Plant Fund. These projects include the Chiller Plant upgrade, control and lighting upgrades throughout campus and K-Wing.</p> <p>For fiscal year 2025/2026 state appropriations, the Governor has proposed a 4% increase. We have not heard anything yet from the House or the Senate.</p>

### **ACCEPTANCE OF THE ESTIMATE OF PROPERTY TAXES AND STATE APPROPRIATIONS FOR THE FISCAL YEAR 2025-2026 (BA5604)**

It is the recommendation of the Administration that the Board of Trustees accept the estimate of property taxes of \$29,606,924, and state appropriation of \$19,473,284 necessary for the next fiscal year to comply with Section 141 of the Community College Act of 1966.

### **APPROVAL OF D- WING OFFICE CONSTRUCTION PROJECT FROM WOBIG CONSTRUCTION (BA5605)**

It is the recommendation of the Administration that the Board of Trustees approve the purchase order with Wobig Construction in the amount of \$282,282 and authorize a total project budget of \$315,510 to ensure comprehensive project completion of the D Wing Office Renovation.

Registration for spring semester is underway. To-date, 4,129 students are registered (479FT, 3660PT). We projected 22,677 contact hours for the spring semester and as of today, we are

at 121% (27,512 contact hours) of projection.

  - Associate of Applied Science (AAS), Associate in Applied Arts (AAA), Associate in Business Studies (ABS) Career and technical degrees will articulate to the **Bachelor of Science (BS) in Technology Management**.
  - Associate of Arts (AA) or Associate in General Studies (ABS) degrees with Cyber Security emphasis, will articulate to the **Bachelor of Science (BS) in Cybersecurity**.
- Articulation agreement with **Wayne State University (WSU)**, new, effective April 2025:
  - **Bachelor of Arts (BA) in Global Studies** transfer pathway was created to accept Delta’s Associate in Arts, Associate in Science, or Associate in General Studies, along with the International Studies Advanced Certificate.

- Delta's Marketing Department won 27 awards in five national competitions.   - While total enrollment is dominated by the larger universities, the No. 1 college for each school district varies. MSU was the most popular college in 44 school districts. Community colleges fill the rest of the top 10, however.
  - **Delta College in Bay City, with satellite campuses in Saginaw and Midland, is second overall with 39 districts picking it the top community college.** It's not until 15th-place Ferris State that a four-year institution returns to the top-college list.
