Call to Order	Committee Chair, D. Middleton called the meeting to order at 3:31 pm.
Approval of Agenda	M. Wood made a motion to approve the agenda. S. Gannon seconded the motion.
	The motion passed unanimously.
Public Comment	Committee Chair, D. Middleton called for public comment.
Discussion of President's Compensation	Committee Chair, D. Middleton said that the purpose of this meeting was to put together a compensation recommendation for M. Gavin.
	J. Foco distributed a document outlining M. Gavin's contract history and proposed increases for this year. He noted that M. Gavin prefers that his increase stay in line with overall College trends.
	The committee discussed the various components of the contract. J. Foco stated that M. Gavin is under the threshold for the 403b. Regarding life insurance, coverage is maxed out within both standard limits and those provided by the College's insurance carrier.
	There was also discussion on the increases being equitable to M. Gavin's performance evaluation. D. Middleton said that his stellar evaluation aligns with the proposed compensation.
	S. Gannon made a motion to recommend the following increases to M. Gavin's compensation as follows: a 3.5% increase in base pay; an increase of \$6,000 to his employer contribution in his 403b; an increase of \$1,000 to his auto allowance; an increase of \$2,000 to his community support allowance; and his life insurance to stay at 2x his annual base pay. D. Middleton seconded the motion.
	The motion passed unanimously.
	D. Middleton said the recommendation will be going to the full Board for a vote tomorrow.
