It is the recommendation of the Administration that the Board of Trustees approve the purchase order with A Wynn Roofing in the amount of \$417,300 and authorize a total project budget of \$495,172 to ensure comprehensive project completion of the N Wing Roofing Replacement.

A. Baldwin made a motion to approve the recommendation. A. Thomas seconded the motion.

M. Rowley asked if it would be beneficial to have the free scan conducted. R. Young replied that if we conduct the scan we have to go back out to bid.

A. Clark said that he believes it is worth the \$8,800 to give the job to a local vendor. R. Young said, to put it in perspective, that we could replace lighting in three wings with that money.

M. Gavin said that we have a fair system that is used for each bid. We award bids consistently using that system. The difference this evening is that we have a vendor present.

R. Young said that if we build in a local factor, we drive other businesses and competition away. In the long run, cost will rise. If bid competition goes away it impacts the College's ability to do projects.

M. Rowley said that the Board has a fiduciary responsibility to the College. In addition, he doesn't want to destroy the integrity of the process.

B. Handley-Miller asked if we largely choose local. R. Young said that we choose the lowest qualifying bid.

M. Gavin said that he appreciates the conversation and suggested that the Board have a conversation about the process in the future to help with understanding of the parameters.

Motion passed unanimously with a vote of 7 in favor, 1 opposed. A. Clark voted in opposition to the motion.

D. Middleton said that the Board makes the decisions when it comes to the search. D. Middleton said she is looking forward to working with Dr. Harris from ACCT. She said that ACCT has led 750 successful searches to-date.

M. Rowley made a motion to approve the updated Presidential Search Advisory Committee. B. Handley-Miller seconded the motion.

We projected 76,999 contact hours for the winter semester and are currently at 87% of projection. Winter semester begins on January 10, 2026.
