- Call to Order** Board Chair, S. Gannon called the meeting to order at 5:03 pm.
- Approval of Agenda** Board Chair, S. Gannon, called for the approval of the agenda. D. Middleton made a motion to approve the agenda. B. Handley-Miller seconded the motion.
- The motion passed unanimously.
- Public Comment** Board Chair, S. Gannon called for public comment.
- Deliberate and Select First Choice Candidate – Delta College President (BA5680)** Board Chair, S. Gannon started with a summary of the process that has been followed for the presidential search. She also expressed a big thank you to everyone who has been involved along the way.
- D. Harris, from ACCT, said that reference checks were conducted on all three candidates. They were overwhelmingly positive. He confirmed that all the candidates are still interested in the position and that there were no red flags discovered for any of the candidates.
- The Board then ranked each candidate. Their first choice received 5 points, second choice, 3 points; and third choice, 1 point. The results of the ranking (not an official vote) resulted in Dr. Michelle Allmendinger receiving 33 points, Dr. Reva Curry receiving 11 points, and Dr. Adam Cloutier 19 points. The Board Members engaged in an open discussion about the candidates, sharing strengths and weaknesses for all of them.
- D. Middleton made a motion to offer the position of President for Delta College to Dr. Michelle Allmendinger, subject to a successful negotiation of a contract. A. Thomas seconded the motion.
- The motion passed unanimously.
- (BA5681)** B. Handley-Miller made a motion to direct the Board Chair working with counsel and the Board Treasurer, to negotiate terms and conditions of the presidential contract to be approved by the Board. D. Middleton seconded the motion.

M. Nash asked if there was an end date to A. Ursuy's term as Interim President. A. Ursuy stated that the date is July 1 or sooner.

M. Rowley asked about the farmhouse being part of the contract. S. Gannon noted that it would be part of the negotiation process.

The motion passed unanimously.

She also thanked the community members who served on that committee. She is grateful for her fellow trustees, and she hopes that Board Chair, S. Gannon, can now get some rest.
