CALL TO ORDER	Board Chair Gannon called the meeting to order at 7:00pm.

APPROVAL OF DOMESTIC WATER HEATER REPLACEMENT PROJECT FROM	It is the recommendation of the Administration that the Board of Trustees approve the purchase order with Remer Mechanical in the amount of \$243,000 and authorize a total project budget of \$272,300 to ensure comprehensive project completion of the Domestic Water Heater Replacement project.

APPROVAL OF LIFECYCLE ROOFING REPLACEMENT PROJECT FROM BROWN & SON ROOFING (BA5708)

It is the recommendation of the Administration that the Board of Trustees approve the purchase order with Brown & Son Roofing in the amount of \$953,239 and authorize a total project budget of \$1,170,843 to ensure comprehensive project completion of the Lifecycle Roofing Replacement project.

M. Nash made a motion to approve the recommendation. A. Baldwin seconded the motion.

Motion passed unanimously.

STUDENT SUCCESS: Setting Students Up for Success: Multicultural Graduation

A student success report, "Setting Students Up for Success: Multicultural Graduation," was presented by Chris DeEulis, director of BEDI.

Chris discussed how several college groups are helping graduates celebrate their cultures and identities by providing stoles and cords to wear during commencement. In addition to Kente cloth, sarape and military branch stoles, the college is adding stoles recognizing Native American, LGBTQ+ and disability identities.

The stoles and cords are distributed during a special event for graduates and their families. Graduates are individually recognized and presented with the stole and cords they selected. Last May, approximately 100 graduates and family members attended the event, and 300 cords and stoles were distributed.

PRESIDENT'S REPORT

Enrollment Report

The Spring/Summer 2026 semester ends on August 20. As of today, 4,081 students are enrolled (3,556 part-time, 525 full-time). We projected 21,482 contact hours for the spring term and we are at 118% of budgeted projection (25,384 contact hours). We projected 4,647 contact hours for the summer term and we are at 108% of budgeted projection (5,005 contact hours).

Registration is underway for the Fall 2026 semester. To date, 7,830 students have registered (5,177 part-time, 2,653 full-time). We projected 79,039 contact hours for the fall semester and we are at 103% of budgeted projection (81,030 contact hours). There will be some fluctuation because tomorrow is the second drop date for non-payment.

Fall classes begin on August 29.

EMU, Bachelor of Science in Paralegal
Under this agreement Eastern (EMU) will waive their rule that 60 hours must be completed at the university and allow Delta's entire degree, plus electives, to transfer and apply.
 - *Benefits to students:*
 - *Entire Delta ABS degree will transfer and apply to the BS.*
 - *Additional electives, up to 87 total credits, will transfer and apply.*
 - *Students can complete the MTA using electives.*
 - *Only 33 credits are needed at EMU to complete the BS.*
 - *Courses delivered in a hybrid format, both face-to-face and online*
 - *EMU paralegal program ranks No. 15 in the U.S., No. 1 in Michigan.*
 - *The EMU paralegal program is approved by the American Bar Association.*
 - *Students will intern at an attorney-supervised Legal Resource Center.*
 - *Scholarships are available to qualifying students.*
 - *High demand occupation, U.S. Bureau of Labor predicts there will be about 37,300 paralegal openings each year, median starting salary \$62,000.*
 - This agreement was reviewed and approved by Heidi Helgren, professor & coordinator Management/Legal Support, and Sue Roche, associate dean, Business & Technology Division.
 - This articulation agreement originated in 2005; it has an annual administrative review for changes and renews every four years.
